The next session of Brother Martin's Driver's Education Course will take place from **June 6 - June 12 (NO Saturday or Sunday)** located in Room 200 in the Cor Jesu Building. The cost of the 30-hour course, including the driving portion, is \$430. Students must be least in eighth grade and 14 years and nine months by June 6th. All students must complete the registration form and sign-up sheet found on BMHS website under Quick Links and return the completed forms as soon as possible with payment to the Student Services Office. Students may also pick up a sign-up sheet at Student Services.

The class times will take place:

- *Thurs., June 6 from 8:00 - 3:00 PM
- Fri., June 7 from 8:00 - 12:00 PM
- *Mon., June 10 from 8:00 - 3:00 PM
- *Tue., June 11 from 8:00 - 3:00 PM
- *Wed., June 12 from 8:00 - 3:00 PM

*1/2 hour lunch breaks on Thursday, Monday, Tuesday and Wednesday

Please bring your own lunch as no lunch is provided.

Please note that there will be a **Mandatory Parent Meeting (1 parent/ legal guardian required)** held on Thursday, May 23, 2018, in Room 200 (located on the 2nd floor of the Cor Jesu building) at 6:00 PM.

Please read below about the new Temporary Instructional Permit required by the OMV.

The Louisiana Office of Motor Vehicles (OMV) will implement the Temporary Instructional Permit (TIP) effective **September 4, 2018**.

A TIP is a class "E" credential that will indicate "Temporary Instructional Permit" in the header. All students enrolled in a driver education or pre-licensing course on or after the effective date must present a TIP. Every student must pick up a verification of enrollment form from the Guidance Office *prior* to going to DMV for TIP. In addition, the student must have the TIP in their possession when operating a motor vehicle during the 'behind the wheel' portion of the instruction and when accompanied by a licensed driver education instructor or during the administration of a road skills test.

A copy of the TIP must be maintained in the student's file. The issue date of the TIP, enrollment date and instruction date will all be verified for compliance.

As all Office of Motor Vehicles identification requirements apply to the TIP, it will no longer be necessary to maintain copies of birth certificates, social security cards, etc. This will only be necessary if there is not a clear connection of the domiciliary parent to the student.

Upon completion of driver's education, the TIP will be surrendered to OMV along with proof of completion of the appropriate driver's education course and any other necessary documents. There is no additional cost to convert from the TIP to a Learner's Permit for a minor.

Step # 1 Temporary Instructional Permit (TIP) as of 9/4/18. Cost of TIP is \$32.25

Minor Students (14 - 17 years old)

- Original or State Certified Birth Certificate (no photocopies) and another primary document or two secondary forms of identification.
- Social Security Card
- School Enrollment Form- student must obtain from Guidance Office
- Original or Court Certified Custody Papers (if there are any)
- Legal Custodial/Domiciliary Parent/Guardian with their Driver's License or State ID Card

Step # 2 Louisiana Learner's Permit NO ADDITIONAL COST!!!

Second step in the Louisiana graduated driver's license (GDL) program is completing driver's education and obtaining your learner's permit. For information about driver's education requirements in Louisiana, please visit DMV.ORG website.

To obtain for your learner's permit, visit your local Louisiana DMV office with your parent or legal guardian and provide:

- Your Social Security card and Birth Certificate
- School Enrollment Form- student must obtain from Guidance Office
- Successful Certificate of Completion in SEALED ENVELOPE (TO BE OPENED ONLY BY DMV) that proves you have completed 38 hours of driver's education, including:
 - 30 hours of classroom instruction.
 - 8 hours of behind-the-wheel instruction.

Step # 3 Road Skills or Driving Test to obtain Driver's License Cost is ~\$30.00

If you have a learner's permit, you will be able to upgrade to an intermediate license once you:

- Are at least 16 years old.
- Have held your learner's permit for at least 180 days.
- Submit a signed statement confirming that you have completed a total of 50 hours of supervised driving, including 15 hours completed at night.
 - Must be completed with your licensed parent, legal guardian, or other adult who is at least 21 years old.

You'll also need to pass a road test at a third party testing facility. I recommend ABC Title or any third party tester. You'll need to provide your own car and have:

- A current safety inspection sticker.
- A valid registration sticker and certificate.
- Proof of Louisiana car insurance.
- Provide your learner's permit and Birth Certificate.
- School Enrollment Form- student must obtain from Guidance Office.
- Pass a vision exam.
- Payment for the upgrade fee and any local fees.
