Brother Martin High School Summer Session 2025

Frequently Asked Questions

What is Brother Martin's Summer Session?

Summer Session is a four-week summer program for Brother Martin students who have not earned credit for a course. Students will receive instruction, complete classwork and homework, and take guizzes, tests, and an exam.

When does the 2025 Summer Session take place?

Summer Session classes begin on Monday, June 2nd, and end on Friday, June 27th. There are nineteen days of classroom instruction and one exam day.

What time during the day is the Summer Session?

Morning Summer Session begins at 8:00 am and ends at 11:00 am Afternoon Summer Session begins at 11:30 am and ends at 2:30 pm.

How much does the Summer Session cost?

A 1/2 credit (1 and 1/2 hours a day) is \$375.00.

A 1 credit (3 hours a day) is \$625.00.

A 1 and 1/2 credits (4 and 1/2 hours a day) is \$875.00.

A 2 full credits (6 hours a day) is \$1,125.00.

How do I register for the Summer Session?

Registration for Summer Session takes place on Friday, May 30th, from 10:00 am to 2:00 pm Full payment for the Summer Session is due at the time of registration.

When will I know my son's schedule?

Summer Session schedules can be picked up at the time of registration on Friday, May 30th, from 10:00 am to 2:00 pm.

When will my son's class take place during the day?

The time of your son's class(es), morning or afternoon will be determined by the Summer Session schedule, which is only finalized a day or two before the program begins. A student who is denied the equivalent of 1/2 credit will be in the Summer Session for 1 and 1/2 hours daily; a student who is denied the equivalent of 1 credit will be in the Summer Session for 3 hours daily.

How many credits can a student complete in Summer Session?

A student can complete up to 2 full credits with 6 hours of academic work daily

What if my son is denied the equivalent of more than two full credits?

A student who fails to earn credit for two or more full credits, unfortunately, will receive Fs in the courses and will not be able to return to Brother Martin for the following school year.

If my son is denied a non-high school credit course, such as English 8 or Religion, does he have to attend Summer Session?

Yes, he does. The same scheduling and cost apply to ALL failed courses, regardless of whether they are for high school credit.

How will my son's grade be determined in Summer Session?

Your son's Summer Session work will earn a numerical average that will be averaged with his school year grade to determine a "new" average. This new grade will take the place of the "SS (Summer Session)" in the first and/or second-semester column.

If my son fails the first semester and passes the second semester, does he have to go to Summer Session?

This situation depends on his Final Year average. If he fails the first semester and passes the second semester and passes for the Final Year average, he DOES NOT have to attend Summer Session.

If a student goes to Summer Session, is he guaranteed to receive credit?

No. A student must pass (with at least a 70 "D") the Summer Session work for him to convert the incomplete semester into a passing grade.

What happens if my son fails Summer Session?

If a student fails Summer Session, he fails the specific semester(s) that sent him to Summer Session and thus will not have the appropriate high school credit to be promoted to the next grade level. He will be unable to return to Brother Martin for the next academic year.
